### **COVID-19: Economic Resilience Fund (ERF): Further support for businesses with a turnover of £85k+**

Businesses with a pre-COVID turnover of £85,000+, directly impacted by the restrictions in place during July and August 2021, can apply to the Economic Resilience Fund for financial assistance to help meet their operating costs (excluding staff wages). The fund will reopen from 12:00pm 13 July 2021 until 12:00pm 27 July 2021. You can check your eligibility for this further support by going to:

- Applications for businesses with a pre-Covid turnover less than £85k will open on 26 July 2021 (more details to follow)

### **COVID-19: You can now make June CJRS claims**

Claims under the Coronavirus Job Retention Scheme (CJRS) are now open for pay periods in June 2021. You must submit your claim for June 2021 by 14 July 2021.

Here's a future claim dates reminder:

- for furlough days in July 2021 submit claim by 16 August 2021
- for furlough days in August 2021 submit claim by 14 September 2021
- for furlough days in September 2021 submit claim by 14 October 2021

## **BREXIT: EU Settlement Scheme – the deadline has now passed**

Wednesday, 30 June 2021, was the deadline for applications to the EU Settlement Scheme (EUSS) for EU, EEA and Swiss citizens and their family members, who were resident in the UK by 31 December 2020. From Thursday 1 July 2021, EU, EEA and Swiss citizens and their family members are now required to obtain a valid UK immigration status to be in the UK, either through the EUSS, if they were resident in the UK by 31 December 2020 or are joining a family member, or through a valid visa.
