## **Furlough Scheme Extended**

The Coronavirus Job Retention Scheme (CJRS) – also known as the Furlough scheme – will remain open until March 2021, with employees receiving 80% of their current salary for hours not worked, up to a maximum of £2,500. # Major new employer incentives announced to help recruit apprentices

Economy Minister Ken Skates has announced that businesses in Wales will be able to claim up to £3,000 for each new apprentice they hire under the age of 25. The £3,000 incentive, aimed at helping Wales to recover from impact of COVID-19, will be available to businesses that are employing a young apprentice for at least 30 hours per week. Welsh businesses could also receive £1,500 for each new under 25 year old apprentice they employ for less than 30 hours a week. For more information, go to:

#### **EU Settlement Scheme**

European citizens are part of the makeup of the Welsh tourism and hospitality workforce, therefore the Welsh Government is urging all businesses to support their EU employees in making an application to the EU Settlement Scheme (EUSS). If you employ EU, EEA or Swiss citizens, they, and their families, must apply to the EU Settlement Scheme to continue living in the UK after 30 June 2021.

### Coronavirus regulations from 9 November 2020

Almost all businesses will be allowed to reopen but with measures that will need to be put in place to operate safely. Businesses in Wales have been encouraged to display the QR code posters for customers to use the NHS Covid-19 app whilst in their premises. However, businesses operating in a high risk setting are required to collect contact information. High risk settings include where customers and visitors will spend a long time on the premises, and/or potentially come into close contact with people outside of their household (or extended household if they have formed one). Examples of high risk settings expected to collect and retain contact information include:

- hospitality, including pubs, bars, restaurants and cafes
- cinemas
- close contact services including hairdressers, barbers, beauticians, tattooists, sports and massage therapists
- swimming pools, indoor fitness studios, gyms, spas or other indoor leisure centres or facilities
- bingo halls
- casinos
- places of worship
- Information to be collected by these businesses

The legal requirement is to collect the person's name and information sufficient to enable the person to be contacted, to inform them that they may have been

exposed to coronavirus at the premises (including a telephone number and the date and time at which the person was at the premises).
