# Relaxation of COVID-19 restrictions – updated timetable

The Welsh Government confirmed last week that elements of its programme to relax COVID-19 restrictions will be accelerated.

Key dates and points for business are:

### Monday 12 April 2021:

- All remaining shops to reopen, completing the phased reopening of nonessential retail
- All remaining close contact services to open, including mobile services
- Travel restrictions between Wales and England have been lifted.
  (Restrictions on travel to and from countries beyond the United Kingdom, the Channel Islands, the Isle of Man and the Republic of Ireland remain in place.)
- Wedding 'show-arounds' by appointment are allowed

To be confirmed on 22 April 2021 subject to the public health situation remaining favourable:

#### Monday 26 April 2021:

- Outdoor attractions, including funfairs and theme parks, would be allowed to reopen
- Outdoor hospitality can resume, including at cafes, pubs and restaurants. (Indoor hospitality will remain closed except for takeaways)
- Organised outdoor activities for up to 30 people can again take place (previously Monday 3 May 2021)
- Wedding receptions can take place outdoors for up to 30 people (previously Monday 3 May 2021)

Monday 3 May 2021 (previously Monday 10 May 2021)

- Gyms, leisure centres and fitness facilities can reopen. This will include individual or one-to-one training but not exercise classes
- Extended household will again allow two households to meet and have contact indoors (there are no guidelines yet on how this will impact self-contained accommodation)

# Coronavirus (COVID-19): New temporary permitted development rights to support economic recovery

To support the reopening of businesses and their efforts to create safe environments for the public to feel confident to return to the high street, hospitality and tourism sectors, the Welsh Government are temporarily relaxing planning control for specified development through amendments to the Town and Country Planning (General Permitted Development) Order 1995 (the "GPDO").
