Applications for the Cultural Recovery Fund Phase 2 will close at 5:00pm tomorrow, 20 April 2021. Support is available for organisations such as theatres, music venues, recording and rehearsal spaces, heritage attractions, heritage organisations, museums, libraries, galleries, archives, independent cinemas, comedy venues and events to cover the ongoing impact of the pandemic for the period from 1 April 2021 to 30 September 2021.
