Welsh Government December 2020 – January 2021 Restrictions Business Funds

These funds were launched by the Welsh Government in response to the restrictions on hospitality and some other sectors from the 4th of December 2020 and more broadly after Wales entered Alert Level 4 restrictions on the 20th of December 2020. The support covers the impact on businesses during December 2020 and January 2021.

Grants administered by Gwynedd Council.

Support is available to businesses required to close or have suffered a reduction of 40% or more in turnover as a direct result of the new restrictions. Eligible businesses that have not received support, or applied as yet, are being urged to do so by completing a simple form. For more information and to apply, go to:

Grants administered by Business Wales:

The ERF Sector Specific Support (operating cost) package is open, and targeted at Hospitality, Tourism and Leisure (HTL) businesses and associated supply chain businesses that have been materially affected (greater than 60% impact of turnover) by the restrictions introduced in December 2020. The fund

will remain open for 2 weeks from 13 January 2021, or until funds are fully committed. Demand for the Fund has been high – so don't delay! To use the eligibility checker to review the criteria and apply, go to:
