COVID-19 Economic Resilience Fund Sector Specific Grant closes 12:00pm 29 January 2021

The ERF Sector Specific Support Fund, administered by Business Wales, which is targeted at Hospitality, Tourism and Leisure (HTL) businesses and associated supply chain businesses that have been materially affected (greater than 60% impact of turnover) by the restrictions introduced in December 2020, will close at 12:00pm 29 January 2021, or beforehand if funds are fully committed. Support is available to businesses required to close or have suffered a reduction of 40% or more in turnover as a direct result of the new restrictions. Sport Freelancer Fund re-opens

The Sport Freelancer Fund is designed to help freelancers in the field of sport and physical activity recuperate losses which they have experienced as a result of the pandemic. The fund is for freelancers whose work directly delivers activity to participants (e.g. personal trainers, instructor/practitioners and paid coaches) who have lost at least £2,500 of income due to the COVID-19 pandemic. Freelancers who meet eligibility criteria will receive £2,500 to recuperate their losses. It should be noted that if you received support through round 1 of the Freelancer Fund, you ARE NOT eligible for support in this second round. For more information, and to apply, go to:
