TAX: HMRC late payment interest rates to be revised April 2023

As a consequence of the Bank of England's recent base rate rise to 4.25% from 4%, HMRC interest rates for late payment and repayment will increase. These changes will come into effect on 3 April 2023 for quarterly instalment payments and on 13 April 2023 for non-quarterly instalments payments. For more information, go to:
