### Purpose of the annual report:

The aim of the Annual Report is to assist the electorate to become better informed of the work and activities of their elected local authority member during the year.

#### Role and responsibilities:

I am a member of the Democratic Services Committee, Corporate Scrutiny Committee, Dwyfor Area Committee, SACRE (Chairman), Porthmadog Harbour Committee, Chief Officers Appointment Committee.

#### Constituency activities:

I have collaborated with the committee of the Porthmadog Ysgol Feithrin to search for a new site.

I collaborated with officers to improve the safety of the pupils' access to Ysgol Eifionydd. We also succeeded to obtain a grant to build a new footbridge that was also suitable for cyclists. Similarly, I collaborated with the staff of Ysgol Eifion Wyn to improve the safety of the pupils near the school entrance.

I arranged a networking evening 'Boosting Businesses' in Porthmadog which was attended by sixty local businesses.

I was the Chairman of the Cob 200 events that ended in the summer 2013, when a sculpture of Maddocks was unveiled.

During the year, I have been a member of a working group that was looking into methods of supporting older people in the Porthmadog catchment area in the future.

Through hard work and collaboration we have succeeded in attracting grant funding to construct toilets and other facilities near the main access to Black Rock Sands – this assisted to obtain the Blue Flag for the beach.

I collaborated with residents of Morfa Bychan to establish a new committee to take responsibility for the field and to look into ways of improving the provision with the assistance of the area's Regeneration Officer.

I arranged an evening for the residents of Morfa Bychan to discuss the Council's recycling arrangements.

I collaborated with officers to improve safety by constructing an island that would ensure better access for traffic from all directions at the Penamser junction. I also worked with officers and Friends of Morfa Bychan to improve road safety.
