

## **ESSENTIAL WORKS LOAN**

- A discretionary loan, up to a maximum of £10,000 to undertake essential or urgent repairs to home owners who would otherwise be unable to afford the costs involved in dealing with hazards arising from essential and urgent repairs.
- To qualify, applicants **must** be in receipt of a means tested benefit **and** the repair required would be considered a Category 1 Hazard in accordance with the Housing, Health and Safety Rating System, as determined by an Officer of the Housing Department.
- Appropriate benefits are Income Support, ESA (income based only), Council Tax Benefit (excluding single person discount); Jobseekers Allowance (income based only), Working or Child Tax Credit (with an annual income of less than £15,050 per annum), Universal Credit, Guaranteed Credit or Pension Credit.
- Applicants must show that they have tried to address the problem via their buildings insurance company.
- Loan repayable in full without exception when the property is sold.
