NOTICE OF PROPOSAL TO MAKE REGULATED CHANGES TO YSGOL Y FAENOL

YSGOL Y FAENOL, PENRHOS ROAD, PENRHOSGARNEDD, BANGOR, LL57 2NN

Notice is hereby given in accordance with section 42 of the Schools Standards and Operational (Wales) Act 2013 and the School Organisation Code that the Governing Body of Ysgol y Faenol, after consultation with such persons as required, propose to extend the site by increasing the capacity of Ysgol y Faenol, Bangor, LL57 2NN, from 186 to 315 pupils from 1 January 2021. The school is maintained by Gwynedd Council.

The Governing Body of Ysgol y Faenol undertook a period of consultation before deciding to publish this proposal. A report on the consultation containing a summary of the issues raised by consultees, the proposers responses and the views of Estyn is available on the Ysgol y Faenol website www.ysgolyfaenol.cymru in addition to the Councils website www.gwynedd.llyw.cymru/modernisingeducation

It is proposed that this proposal is implemented on **1 January 2021**. The proposal will be implemented by the Local Authority.

The admissions authority for the 3-11 school will be Gwynedd Council. Pupils will be admitted to the school by Gwynedd Council in accordance with the Admissions Policy. The admissions arrangements for the school will not make provision for selection by aptitude or ability (pupil banding).

The number of pupils in the school is 219 in line with January 2018 figures including Nursery pupils. The pupil capacity for the school (referred to the Welsh Government Circular 21/2011 'Measuring the Capacity of schools in Wales') is 186. After implementation of the proposal there will be a provision for 315 pupils from Reception to year 6 and 30 full time Nursery pupils.

Admission numbers for 1 January 2021 will be 45 reception to year 6 pupils and 30 nursery full time pupils.

Any person may object to the proposal, within a period of 28 days from the date which the proposal is published, that is by **21 December 2018**.

Objections should be sent in writing to the Chair of the Ysgol y Faenol Governing Body through the Modernising Education Office, Gwynedd Council, Caernarfon, Gwynedd, LL55 1SH or by sending an e-mail to modernisingeducation@gwynedd.gov.uk.

The Governing Body of Ysgol y Faenol will publish a summary of any objections made (and not withdrawn in writing) within the objection period, together with their observations thereon, within the period of 28 days after the end of the objection period.
