Re: Increasing the capacity of Ysgol y Faenol

On Thursday, 24 January, 2019, the Governing Body of Ysgol y Faenol approved the proposal to increase the capacity of Ysgol y Faenol to 315 pupils from **1 January 2021**.

As a result of a delay in the tendering process, and in accordance with Section 55 (3) (a) of the School Standards and Organisation Act (Wales) 2013, we have made a decision to delay the proposal implementation date to **1 September 2021**.

The reason for delaying the implementation date of the proposal is that it would be unreasonably difficult to implement on the original implementation date as no valid bids were received in the original tender process and therefore there is a need to re-tender the construction contract.
