BREXIT: Businesses risk losing ability to import goods

Businesses submitting import declarations must use the Customs Declaration Service from 1 October 2022, when the Customs Handling Import and Export Freight (CHIEF) system will close for import declarations, and should check that their customs agents are ready to use the Customs Declaration Service.
