

## ANNUAL REPORT 2013/14

**Purpose of the annual report:**

The aim of the Annual Report is to assist the electorate to become better informed of the work and activities of their elected local authority member during the year.

**Role and responsibilities:**

Chairman of the Democratic Services Committee, Member of The Council, Corporate Scrutiny Committee, Local Joint Consultative Committee, Bangor Project Team and Ogwen Area Forum

**Constituency activities :**

I receive a considerable number of telephone calls, emails and letters from residents seeking help and advice on a wide range of issues from Planning to Refuse Collection.

I attend the Planning Committee as the local member as and when anything concerning Garth is discussed. In Garth we have been able to successfully influence the Design Commission and Developers not to go ahead with five 7 - storey buildings on Phase 2 of the former Dickies' Boatyard as well as the student accommodation blocks at Bron Derw.

I have organised a series of public workshops. There was an 'Introduction to Planning' evening where we had experts talking to us about the planning process - from a planning application through to the responsibilities and powers of your local councillors, Bangor City Council and Gwynedd Council, through to the Joint Local Development Plan and how to contribute. There were further sessions on Understanding the Former Dickies Boatyard Site – Constraints, Limitations and Possibilities. Following the latest Public Consultation by Watkin Jones, we passed our comments to Watkin Jones Group and are currently awaiting their revised plans.

I have been working towards resolving the issue of Love Lane both in terms of the road surface and the safety of users, especially for pedestrians. I was delighted when Gwynedd Council undertook repairs and resurfaced Love Lane in October, and pleased that, following Gwynedd Council's Feasibility Study and Traffic Survey, there was a Public Consultation on the possible alternative methods of a safe route for pedestrians.

I regularly walk the ward and I have undertaken a detailed Street Scene Survey in Garth; it is disappointing that there is so little money when it is necessary to repair so many potholes and patch road defects. But it is useful to have a inventory which can be updated as necessary.

I am on the Gwynedd Working Group Waste and Recycling Initiative looking at Bangor. This Working Group is made up of Gwynedd Officers, Councillors, and the University including the Students' Union. In Garth, and some areas of Bangor, much of the housing stock has been adapted to become Houses of Multiple Occupation for students which can exacerbate waste issues in particular. We are seeking to improve the current situation of food waste, recycling and rubbish and to achieve cleaner streets, because in the near future due to EU Regulations we will be unable to send our rubbish to landfill.

**Other initiatives and activities :**

I am Chairman of Garth Community Centre where we provide classes and activities which we hope will interest the local people. We believe that this also provides a work opportunity for anyone who provides classes as well as a small income for the Centre. The Centre acts as a focal point for the Community.

I represent Garth as a Bangor City Councillor and have attended 13 meetings with apologies for 3 meetings of the possible 17 meetings.

I represent Bangor City Council on the Bangor University Liaison Group.

I am the Treasurer for the Bangor Soest Twinning Association. Over the past 40 years we have had many exchanges – schools, choirs, councillors, sport and other groups have enjoyed their exchanges and made firm friends. We celebrated our 40<sup>th</sup> anniversary in September with an exchange of old friends and Mayors. We hold several fund raising activities each year.
