Subject : Approval to implement the CCTV project

Recommendation for the Decision : Approve the extension of CCTV in Bangor, Caernarfon and Pwllheli, to be funded through the Shared Prosperity Fund.

Reason and justification behind the Decision : The implementation of this plan will enable us to extend our CCTV systems in areas where we already have a presence. The locations of the new cameras have been chosen following extensive conversations with the Police as experts on areas where crime occurs or where members of the public feel unsafe. The result of this project will be a reduction in crime in the neighborhood and improved feelings of safety in our towns. The financial implications are set out in Appendix 1.
