Dydd Iau, 24 Ionawr, 2019, cymeradwyodd Corff Llywodraethol Ysgol y Faenol y cynnig i gynyddu capasiti Ysgol y Faenol i 315 o ddisgyblion yn weithredol o **1 Ionawr 2021**.

Cynhaliwyd cyfnod gwrthwynebu statudol rhwng 23 Tachwedd 2018 a 21 Rhagfyr 2018 i gynyddu capasiti Ysgol y Faenol o 186 i 315. **Ni dderbyniwyd unrhyw wrthwynebiad yn ystod y cyfnod gwrthwynebu.**

### Re: Increasing the capacity of Ysgol y Faenol

On Thursday, 24 January, 2019, the Governing Body of Ysgol y Faenol approved the proposal to increase the capacity of Ysgol y Faenol to 315 pupils from **1 January 2021**.

A statutory objection period was held between 23 November 2018 and 21 December 2018 to increase the capacity of Ysgol y Faenol from 186 to 315. **No objections were received during the objection period.**

As part of the proposed investment the proposal will:

- Build a school to the 21st Century Schools standards, which would provide a learning environment of the highest standard for Ysgol y Faenol pupils.
- Improve the working environment for staff by making improvements to the existing building
- Reduce building and maintenance costs.

There will be regular contact with stakeholders affected by the decision in order to update them on the process.
