It is intended to do this by transferring the school to a new building to be built on the site adjacent to the existing building. The school is maintained by Gwynedd Council.

Gwynedd Council undertook a period of consultation before deciding to publish this proposal. 
The number of pupils in the school is 339 in line with January 2018 figures including Nursery pupils. The pupil capacity for the school is 240. After implementation of the proposal there will be a provision for 420 pupils from Reception to year 6 and 30 full time Nursery pupils. Admission numbers for 1 September 2020 will be 60 reception to year 6 pupils and 30 nursery full time pupils.

Subject to parental choice current pupils attending Ysgol Glanadda and Ysgol Babanod Coedmawr will transfer to Ysgol y Garnedd. The 3-11 school will be a Community Welsh Medium School for girls and boys between the ages of 3 and 11 located near the current school site of Ysgol y Garnedd.


